**County Funding**: Jan, Deb and Amber met with Hawn Library on June 28 to discuss inequity of county funding split. Following DFL Board discussion of the meeting and outstanding issues, the consensus was that DLF send letter to Hawn requesting that their Board vote for a more equitable split (40/60%). DFL Board does not recommend meeting with Hawn in the fall. Any further meeting should take place in a neutral setting – perhaps NCLS offices. Teresa G made a motion that a letter stating such be sent to Hawn, Tresa seconded. All approved.

**Email from NCLS:** "Last year we received a 2% increase to put toward the cost of the fiber project. This year, with automation being one of the new minimum standards coming from DLD, an increase in county funding would help defray the startup cost for the libraries in Jefferson County that aren't yet automated. A 3% increase of the current funding (\$171,666) would come out to just over \$5,000. If awarded, those funds could come to NCLS for one year only to help the non-automated libraries meet this new minimum standard. In this scenario, NCLS would only receive the increase in 2019; in future years, the total amount would be distributed among all 25 libraries according to your funding formula."

Smart Schools Bond Act through TI School District ... hopefully money for Hot Spots.

### **New Business**

Automation is mandated by the state within 3 years.

NCLS is purchasing new Meraki wireless access point at no charge to the libraries.
